### Rules of conduct and instructions

- Only players who have reached the age of 18 are allowed to be in sight of the playing field and to play on the premises of FunSportEvents®. No exceptions are possible.
- Irrespective of any instruction given by our staff, the posted rules and company rules apply. Each participant must familiarize oneself with them independently. If a participant is not able to do so, our staff must be informed.
- Safety is of paramount importance! Physical contact and/or collisions with other participants must be avoided at all costs.
- Each participant must act responsibly so that no other participant is endangered.
- The rental equipment is fragile and must therefore be always treated with care. Own equipment can be brought along at any time.
- It is forbidden to play paintball or load the marker after drinking alcohol or consuming intoxicants.
- Paintballs can be bought from us or brought in. It is forbidden to bring and play paintballs in any shade of red (e.g. pink/pink/purple/bordeaux/etc.). This applies to both the shell and the filling.
- Camouflage clothing in any form is prohibited. Our staff will decide on the admission of clothing to the game.
- The instructions of our staff must be always followed. Failure to follow instructions may result in the termination of participation or the game. In this case, no refund of participation or rental fees will be made.

#### General requirements and procedure:

- ▶ I am aware that staying and playing on the site is at my own risk and that equipment and clothing may become soiled. No liability is accepted for damage to persons or clothing. I hereby release FunSportEvents® from any liability.
- ▶ Persons with chronic illnesses or any other health or physical limitations must pro-actively inform our staff in advance. Pregnant women and persons with heart problems and/or high blood pressure are expressly advised not to participate.
- ▶ The equipment is provided for a contribution towards costs (already included in the package prices). Sturdy shoes with ankle protection are recommended.
- ▶ Depending on the number of participants, groups will be formed. The aim is to enable as many participants as possible to play per round; due to this, we will add people randomly to fill up the groups. Therefore, it cannot be guaranteed that only people from the same group will play together.
- ▶ The aim of the game is to capture the flag or to press the buzzer. It is irrelevant how many players of the opposing team have been marked.
- ▶ It is forbidden to shoot at one of the referees (marshals). Outside of the playing field, ALWAYS keep a suitable running sock on the marker.
- ▶ The shooting of paintballs is only allowed in the designated areas. Anyone who shoots directly or intentionally at windows or electrical installations, or attempts to shoot outside the playing field (with or without paintballs), will be immediately expelled from the hall without refund of any amounts already paid.
- ▶ The player shall independently ensure that his or her shooting energy does not exceed the legally mandated force of 7.49 joules (approx. 214 fps). Should players bring their own marker onto the premises of FunSportEvents®, they hereby assure that the marker complies with all legal requirements. The set firing speed must be proven to the person in charge of the playing field at any time upon request.
- ▶ A special paintball mask must be always worn by all persons on the playing field and in the immediate vicinity of the nets. We recommend the wearing of hearing protection as well as knee, elbow and neck protection, and the covering of all parts of the body. The playing field may only be entered with adequate protective clothing.

- ▶ For safety reasons, the hall operator reserves the right to confiscate markers if it must be assumed that a person is no longer able to use it safely or if a risk to him-/herself or others can no longer be ruled out.
- ▶ Players ensure that any compressed air tanks they bring onto the premises of FunSportEvents® are TÜV tested and have a valid TÜV certificate. Players are obliged to report any damage to the container immediately. FunSportEvents® reserves the right not to fill the high-pressure cylinder if it is not in perfect condition or if the safety of the players and staff is endangered. Compressed air is not breathing air and is only suitable for industrial purposes.

#### General conditions of participation:

Without prejudice to the foregoing provisions and the following limitations of liability, we shall be liable without limitation for damage

- to life, body and health which are based on a negligent or intentional breach of duty by our legal representatives or vicarious agents,
- which are based on intentional or grossly negligent breaches of contract or fraudulent intent on the part of our legal representatives or vicarious agents or
- which result from a breach of such contractual obligations, the observance of which is of particular importance for the purpose of the contract;

if you are a corporate client, however, only to the extent of the damage typically arising in transactions of this kind. Any further liability is excluded regardless of the legal nature of the claim asserted. Insofar as our liability is excluded or limited, this shall also apply to the personal liability of our representatives and vicarious agents. The participant agrees that the operator may take pictures and make sound recordings of him/her and use them for its own advertising purposes, particularly to make them publicly available on the Internet. The participant assigns to the operator the necessary rights of use to the images and the necessary rights of use to the recordings made.

Without prior written permission (available at the counter), players may not make any recordings of any kind on the FunSportEvents® premises, make them available on the Internet or publish them. The pictures, sound or video recordings made by players must be provided to the operator upon request, free of charge.
